ORDER APPROVING END-PAYOR PLAINTIFFS' MOTION FOR DISTRIBUTION OF THE NET SETTLEMENT FUND

WHEREAS, the Court previously granted End-Payor Class Plaintiffs' Motion for Final Approval of Settlement (ECF No. 613, "Final Approval Order");

WHEREAS, the Court, pursuant to the Final Approval Order, appointed A.B. Data Ltd. ("A.B. Data") as the Settlement Administrator and approved the Proposed Plan of Allocation (ECF No. 595-1);

WHEREAS, in accordance with the Settlement Agreement the respective proceeds from the Settlement were deposited into an interest bearing escrow account (the "Settlement Fund");

WHEREAS, the Court previously granted in part End-Payor Class Plaintiffs' Motion for Attorneys' Fees, Payment of Litigation Expenses, and Application for Service Awards (ECF No. 613, the "Fees, Expenses, and Awards Order");

WHEREAS, the fees, expenses, and service awards were paid out from the Settlement Fund pursuant to the Fees, Expenses, and Awards Order;

WHEREAS, in accordance with the Settlement Agreement, A.B. Data has been paid a total of \$202,114.62 for its work with respect to notice and administration of the Settlement through October 31, 2023;

WHEREAS, A.B. Data has made its final determinations concerning claims submitted by Class Members seeking to share in the proceeds from the Settlement pursuant to the Plan of Allocation;

WHEREAS, End-Payor Class Plaintiffs have filed a Motion for Order Approving

Distribution of the Net Settlement Fund ("Distribution Motion") on behalf of the End-Payor

Classes;

WHEREAS, in support of the Distribution Motion, End-Payor Class Plaintiffs have submitted the Declaration of Eric J. Miller in Support of End-Payor Class Plaintiffs' Motion with supporting exhibits (the "Miller Declaration");

WHEREAS, the Court has retained jurisdiction over the parties, the Settlement, and distribution of the remainder of the Settlement Fund; and

WHEREAS, the Court has considered all papers filed and proceedings herein and is otherwise fully informed in the premises.

NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

- 1. The Court approves the administrative determinations of A.B. Data concerning the claims submitted by members of the End-Payor Classes as set forth in the Miller Declaration submitted with the Distribution Motion.
- 2. Accordingly, the Court hereby directs the distribution of the Net Settlement Fund, in the manner described in the Miller Declaration, to the members of the End-Payor Classes who

have submitted claims that A.B. Data determined to be eligible to share in the Net Settlement

Fund, after deducting the fees and expenses referenced in paragraph 6 below.

3. Lead Class Counsel and A.B. Data are directed to execute this Order and shall not

be liable to Class Members for any reason in executing and complying with this Order.

4. Any further claims against the Net Settlement Fund established for purposes of

this Settlement are finally and forever barred.

5. End-Payor Plaintiffs, Lead Class Counsel, A.B. Data, and all persons who were

involved in the review, verification, calculation, tabulation, or any other aspect of the processing

of the claims filed in this action, or who are otherwise involved in the administration or taxation

of the Settlement Fund, are hereby released and discharged from any and all claims arising out of

such involvement, and pursuant to the release terms of the Settlement, all Class Members or any

other persons, whether or not they are to receive payment from the Net Settlement Fund, are

hereby barred from making any further claim against the Net Settlement Fund beyond the

amount allocated to them by the Settlement approved by the Court.

6. The Court authorizes a total payment of \$25,347.25 from the Net Settlement Fund

to A.B. Data for the balance of its fees and expenses incurred and to be incurred in connection

with the notice, administration, and distribution of the Net Settlement Fund.

7. The Court retains jurisdiction over any further application or matter which may

arise in connection with the administration of this Settlement.

IT IS SO ORDERED.
